




## Gov. Kasich's Medicaid Expansion Is Costing Ohioans Billions of Dollars


Gov. John Kasich takes great pride in telling Americans about his unilateral decision to expand Medicaid under Obamacare in Ohio. As he does with Ohio's grossly lagging private sector job market (adding a measly 9,500 jobs in 2015), Gov. Kasich misleads listeners by using figures in isolation (i.e., spending was "less than estimated" ... but still up). He conveniently forgets to tell Americans that (1) his initial and revised enrollment estimates have proven to be horribly low, in fact roughly half of actual enrollment, (2)

that, because of this error, Medicaid will cost Ohioans at least \$3.2 billion more than expected, (3) that, if Washington, D.C. increases the state cost-share as part of a budget deal, Ohioans could face a Medicaid bill of almost \$20 billion, and (4) the federal government is using debt to fund Medicaid expansion, leaving our kids and grandkids with a growing and unsustainable bill to pay. In just three months, Medicaid spending for 2016 is already 20% greater than it was in 2015. It will only get worse.
